
among the communities we serve. Kerry has worked shoulder to shoulder with the ACHCH team through it all.

Program Highlights

Point-in-Time Count 2024

At 5am on Thursday, January 25th more than 1,200 volunteers turned out for Alameda County's biennial countywide Point-in-Time (PIT) homelessness count. This was an unprecedented level of participation from county residents in providing important support for a process that guides critical strategies and policies for addressing and reducing



homelessness. The PIT is a joint effort between the Continuum of Care, the County, cities, and other stakeholders who come together to lead the strategy design and implementation. The PIT is a critical opportunity for the County, Continuum of Care, and cities to understand the magnitude of homelessness in Alameda County, and to utilize the data to allocate resources, inform programmatic decisions, and raise awareness. Many thanks to all the volunteers, staff, cities, and Continuum of Care partners for making the 2024 Point-in-Time Count a success!

Alameda Point Collaborative Groundbreaking Ceremony

On Monday, January 22nd, Alameda Point Collaborative and LifeLong Medical held a groundbreaking ceremony for the Alameda Wellness Campus. Each year, the 3.6-acre campus will serve an estimated 700 unhoused Alameda County residents in a healing center next to Alameda's Crown Memorial Beach and shoreline park. The campus will include a medical respite, community health center, permanent supportive housing, and a homelessness prevention program.

The 50-bed Medical Respite Center will be the first area of the campus to

complete construction. The Center will offer recuperative care and on-site healthcare services for unhoused Alameda County residents 18 years and older who have complex medical conditions or need hospice care. The program anticipates serving approximately 400 unhoused patients annually with:

- Recuperative care stays for health recovery
- Culturally affirming and trauma-informed medical and behavioral health services
- Dignified and compassionate hospice care
- Assistance to secure stable housing and consistent primary care

Home Together 2026 Community Plan Update



The Home Together 2026
Community Plan lays out goals, strategies, and necessary funding investments to dramatically reduce homelessness in Alameda County by 2026 and combat racial disparities in homelessness by fully centering equity. The ambitious Plan calls for the addition of 24,000 housing resources between years 1 and 5, which will cost an estimated \$2.5 billion to operate.

Progress on the **implementation of the Home Together Plan** is tracked and reported annually. Initial findings from the Progress Update for Year 2 (FY22-23) of the Home Together Plan show that:

 Despite housing more people in FY22-23 than in previous years, new people entering homelessness outpaced exits to housing, and the existing need among people experiencing homelessness continues to grow.

 Despite the addition of new resources and accomplishments in years 1 and 2 of the Home Together Plan (such as the addition of more than 1,100 permanent housing opportunities and new federal funding for programs to address unsheltered homelessness) significant and recurring resources and investments are still needed to expand the homelessness response system to drastically reduce homelessness.
